<b>Order Details</b>	By the powers conferred on me under Section 151 of the Local Government Act, 2001, as amended by the Local Government Reform Act, 2014, I hereby order as follows:



1. Having been notified by An Coimisiún Pleanála by letter dated 30th Day of June 2025 of its decision dated the 27th June 2025 to confirm the above Compulsory Purchase Order as per the Modified Schedule submitted to the Oral Hearing on the 3rd April 2025.

2. That the Statutory Notice in respect of the confirmation of the Compulsory Purchase Order be published in accordance with the provisions of the Housing Act 1966 as amended and extended and that notice be served on owners and occupiers of the land being acquired in accordance with Section 78 of the Housing Act, 1966 by registered post. The Confirmation Notice also to be served upon persons not being CPO landowners who made submissions to the CPO and all relevant Prescribed Bodies.
